

**Regulations for Constitution of Faculties, Board of Studies, Meeting of Institutions etc. [as required under Section 8 of the Act]**

**Faculty: R-35**

J & K The Nirma University shall include the faculties of Technology and Engineering, Management, Pharmacy, Sciences, Arts & Humanities, Doctoral Studies & Research, <sup>J</sup>Law, <sup>K</sup>Architecture and such other faculties as may be prescribed from time to time.

**L R-36**

The faculties, *other than* the Faculty of Doctoral Studies & Research <sup>L</sup> and Faculty of Law; shall consist of:

1. Dean of the Faculty concerned – Chairman
2. Head of the Institution concerned
3. All Chairman of the Board of Studies under the Faculty. For Management, Pharmacy and Science, the Chairman/ Convener of the Academic Activities/ Area Committees concerned
4. Upto two members to be nominated by the Director General from each Board of Studies
5. Upto two Technocrat/ Academia to be nominated by the Director General in the Faculty
6. Two members of the Academic Council to be nominated by the Director General

**Note:** In the Faculty of Management, the Dean Academic Programme shall also be a member, if the post filled in.

**R-37**

The functions of the faculty other than Faculty of Doctoral Studies & Research, subject to the provisions of the Nirma University Act, the faculty shall have following functions:

1. To exercise and recommend General Regulations over the Academic Policy of the Faculty and will be responsible for making recommendation to the Academic Council for the maintenance and improvement of Standards of Instructions, Education and Evaluation within the Faculty
2. To maintain co-ordination between different Board of Studies or Areas within the Faculty particularly in the matters relating to Examinations and Teaching Scheme, Curriculum etc.
3. To consider the recommendations of different Board of Studies / Academic Activities / Area Committees in the matter of syllabus, teaching, examination scheme etc. and give final shape to it for the submission to the Academic Council

Subject to the provision of Section 15 of the Nirma University Act, 2003, the Academic Council of the University shall have the following powers, namely:


- i) to exercise control and general regulation over the academic policies of the University and be responsible for the maintenance and improvement of standards of instruction, education and evaluation in the University,
- ii) to consider matters of general academic interest either on its own initiative or on a reference from the Faculty of the University or the Board, and to take appropriate action thereon,
- iii) to recommend to the Board such regulations as are consistent with Nirma University Act regarding the academic functioning of the University including discipline of students,
- iv) to exercise such other powers and perform such other duties as may be conferred or imposed upon it by the regulations.



The above nominations will come into effect from 22.08.2021.

As per the Section 14(2) of the Nirma University Act, 2003, the term of the members other than ex-officio members shall be for a period of three years, i.e., up to 21.08.2024. However, if the nomination is made by virtue of his/her position, then as soon as he/she ceases to hold such position, the nomination will be automatically treated as cancelled. The *ex-officio* member shall continue as member so long as he/she holds the office by virtue of which he/she is a member.

As per the provision of Clause-27 of notification referred at serial 2 above, a nominated member remaining absent without prior permission of the Director General for three consecutive ordinary meetings may be asked to vacate his/her membership.
